- 2. The format for unaudited quarterly results as prescribed in SEBI's Circular CIR/CFD/CMD/15/2015 dated 30<sup>th</sup> November 2015 has been modified to comply with the requirements of SEBI's Circular CIR/CFD/FAC/62/2016 dated 5<sup>th</sup>July 2016, Ind AS and Schedule III (Division II) to the Companies Act, 2013 as applicable to the companies that are required to comply with Ind AS.
- 3. The above financial results were reviewed by the Audit Committee of the Company and approved by the Board of Directors of the Company at its meeting held on 11<sup>th</sup> February, 2019. The statutory Auditors of the Company have carried out a Limited Review of the financial results for the quarter ended 31<sup>st</sup> December, 2018 in terms of Regulation 33 of the SEBI (Listing and Other Disclosure Requirements) Regulations,2015 read with SEBI Circular No. CIR/CFD/FAC/62/2016 dated 5<sup>th</sup> July, 2016.
- 4. The Company is primarily engaged in business of trading of goods and managed organisationally as a single unit. Therefore, according to the management, the Company's operations are carried in a single segment.
- Management is continuing with its efforts to locate the relevant papers and documents for reconciling old outstanding balances of debtors and advances and in the process has been able to adjust substantial funds. Pending reconciliation, no provision for old debts and advances has been made in the accounts.
- 6. Steps are being taken to obtain confirmation for balances of receivables, advances and payables as on 31<sup>st</sup> December, 2018
- 7. Computation of deferred tax asset/liabilities will be considered at the year end.
- 8. Figures of the previous periods have been regrouped/recast, wherever necessary, to conform to the current period's classification.

### REVIEW REPORT TO THE BOARD OF DIRECTORS OF TAI INDUSTRIES LIMITED

- 1. We have reviewed the accompanying statement of unaudited financial results of TAI Industries Limited ("the Company") for the quarter and nine months ended December 31, 2018 ("the statement") attached herewith, being submitted by the Company pursuant to the requirements of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, read with SEBI Circular No. CIR/CFD/FAC/62/2016 dated July 5, 2016. This statement which is the responsibility of the Company's Management and approved by the Board of Directors has been prepared in accordance with the Companies (Indian Accounting Standards) Rules, 2015 (Ind AS) prescribed under section 133 of the Companies Act, 2013 read with relevant rules issued thereunder and other accounting principles generally accepted in India. Our responsibility is to issue a report on these financial results based on our review.
- 2. We conducted our review of the statement in accordance with the Standard on Review Engagement (SRE) 2410, 'Review of Interim Financial Information performed by the Independent Auditor of the Entity' issued by the Institute of Chartered Accountants of India. This standard requires that we plan and perform the review to obtain moderate assurance as to whether the Statement is free of material misstatement. A review is limited primarily to inquiries of company personnel and analytical procedures applied to financial data and thus provide less assurance than an audit. We have not performed an audit and accordingly, we do not express an audit opinion.
- 3. We wish to draw attention to our following observations:
  - a. Substantial amount of debts and advances doubtful in nature have remained outstanding for considerable period of time. A part of such debts have been written off in the accounts. No provision/write off for the balance amounthas been made in the accounts. The Management is continuing its efforts to reconcile such unprovided outstanding debts and advances as stated(Refer Note No 5 of UFRS).
  - b. Balances of Debtors, Advances and Creditors as on 31<sup>st</sup> December, 2018 are subject to confirmation by the parties ( Refer Note No 6 of UFRS).
  - c. Deferred Tax Assets/Liabilities have neither been ascertained nor accounted for in the books of account as on December 31, 2018 (Refer Note No 7 of UFRS).



4. Based on our review conducted as above and read with our comments in paragraph 3(a), 3(b) and subject to our comments in paragraph 3(c) above, nothing has come to our attention that causes us to believe that the accompanying statement prepared in accordance with recognition and measurement principles laid down in the applicable Indian Accounting Standards prescribed under section 133 of the Companies Act, 2013, read with relevant Rules issued thereunder and other recognised accounting practices and policies, has not disclosed the information required to be disclosed in terms of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, read with SEBI Circular No CIR/CFD/FAC/62/2016 dated 5<sup>th</sup> July, 2016 including the manner in which it is to be disclosed, or that it contains any material misstatement.
